DEPARTMENT REPORTS

ECONOMIC DEVELOPMENT DEPARTMENT

Economic Development Committee - Buckmaster for Aknin: Shared a summary of the October meeting which featured the City of Redwood City and YMCA Silicon Valley's project, Veteran's Memorial Senior Center. Buckmaster thanked Gasparini for inviting the speakers to the committee. The next meeting is Tuesday, November 7th at 12 PM. On the agenda: San Carlos Economic Development Update by Megan Wooley-Ousdahl, Principal Planner, City of San Carlos and Office & Life Science: Supply & Demand Update by Ben Paul, Vice Chairman, Cushman & Wakefield.

<u>Transportation & Housing Committee - Greenway</u>: Shared an overview of the September meeting that included presentations on the Bay Pass Pilot Program, WETA's 2050 Strategic Plan and Business Plan, and a potential regional housing bond coordinated by the Housing Finance Authority. The next committee meeting will be on November 9th at 12 PM. On the agenda: 101/84 Interchange Improvement Project by Leo Scott with Gray-Bowen-Scott. Greenway shared this has been a #1 transportation priority for the Chamber and still is. Buckmaster asked Greenway for a quick update on the Port's Ferry Tour.
