
# 2021 CHAMBER'S IMPACT SUMMARY






## **Coffee Talks**

# **COVID Economic Recovery**

The Chamber was honored to partner with CZI and SAMCEDA with the San Mateo County Restaurant, Wineries and Breweries Grant Program through the San Mateo County Strong Fund Program. Through this unprecedented partnership we were able to raise millions of dollars in \$10K grants for our hardest hit industry. Even when the Program was over your Chamber went out and was able raise \$70K additionally for San Carlos Restaurants, Wineries and Breweries that fell short. We would like to thank our members who stepped up and saved seven more San Carlos Businesses.

Redwood City and San Carlos were also chosen as two of the seven pilot cities for the SMC Choose Local shopping app, which benefits small businesses and encourages consumers to shop locally.





### Leadership Program Redwood City · Belmont · Menlo Park · San Carlos

Since 1989, Leadership has been successfully educating participants on issues of vital concern to their communities. This year was no exception as our Leadership session day chairs did a fantastic job organizing excellent speakers, important dialogue, and class activities.

Due to the ongoing COVID-19 pandemic, the 2020-2021 Leadership program was held entirely virtually via Zoom, with the help of Peninsula Television. Thanks to the dynamic day chairs ensuring the topics and content remained relevant and important, the program did not miss a beat engaging and educating the County's future leaders. In June 2021, the Chamber was honored to celebrate both the 32nd and 33rd graduating classes in-person at Devil's Canyon Brewing Company in San Carlos.

By September of 2021, the Chamber had recruited 54 new Leadership students from diverse backgrounds, eager to learn how they can make a difference in their community. In cooperation with local and County health orders, including vaccination reqreuiments, the sessions were held in-person thanks to our partnership with dedicated Chamber members such as Seaport Conference Center and Longfellow Real Estate Partners.

Industries represented in our 34th class include city government, education, banking, engineering, real estate. public safety, and labor.

# **COMMITTEE REPORTS**

The success of our Chamber is due in part to the dynamic committees and their members who are informed and engaged participants.

#### **Economic Development Committee**

In 2021, the Economic Development Committee chaired by Dani Gasparini, once again saw record-breaking attendance at the virtual committee meetings. Committee members engaged in conversations with local and regional economic development drivers about commercial and resendential developments, water supply, the San Carlos East Side Innovation Distirct Plan, Redwood City's Redistricting process, the Sequoia Hotel Project, industry roundtables, and much more.

The Committee was proud to offer a conceptual endorsement for two critical projects in Redwood City: Hines and Habitat for Humanity's 1111-1127 Arguello Project and Lowe's Sequoia Station Project. Both developments will bring a host of benefits to Redwood City, including affordable housing, transit mobility, family recreation space, and child care facilities.

#### **Education Committee**

Our Education Committee, co-chaired by Jason Galisatus and Kathy-Parmer Lohan, is well attended throughout the year with all local Superintendents, as well as Canada College's Interim President Kim Lopez, present at each meeting.

The offices of Assembly Speaker pro Tem Mullin, Assemblymember Berman, and Senator Hill provide monthly legislative updates to committee members. The committee also heard from educational organizations such as the Peninsula College Fund, ReadyNation, and the YMCA. Several meetings also focused on the important discussions of students' mental health, closing the digital divide, and childcare accessibility and affordability.

In December, Senator Josh Becker addressed the committee directly and shared the work he is doing at the State level to create better educational opportunities for our local students.

#### **Governmental Relations Committee**

Our Governmental Relations Committee, chaired by Stacey Wagner, is the perfect way to stay informed of the current legislative issues. These bi-monthly meetings provide members of the business and non-profit communities legislative snapshots from local, county, state, and federal representatives.

#### **Transportation and Housing Committee**

Our Transportation and Housing Forum, chaired by Greg Greenway, provides its committee members with bi-monthly updates on key Transportation and Housing projects and hears from advocacy groups that are continually in the works to improve our County's commute patterns and housing issues.

- Partnered with the City of Redwood City Public Works Department to bring new banners, flags, and Christmas decorations and lighting to the Downtown corridor.
- Developed a Placemaking Task Force to activate public spaces within the district for community building.
