The online portal to apply for funds is expected to begin accepting applications Monday, April 27, 2020 at <a href="https://www.SMCStrong.org">www.SMCStrong.org</a> It is anticipated that approximately 100 businesses will be assisted by the \$1,000,000. All qualifying small businesses, regardless of the immigration status of the business owners, may apply.

Application information will be available in English, Spanish and Chinese. Decisions by SMCU's underwriting department are expected to take seven business days from submission date.



# **Application Statistics**



#### Portal Opened at 12:00pm on Monday, April 27, 2020

- **1,232 submitted applications** (of which 512+ were started in the first 22 minutes)
- **2,798 started applications** (i.e., total unique email addresses entered into portal requesting an application link)
- 1,621 unfinished or abandoned applications (\*this includes duplicate starts and \*\*not eligible apps)

#### **First-Come First-Serve Commitment**

- Applications are all time stamped as of the moment (to the millisecond) an email is entered into the portal to commence a new application
- **187 of the 1,232 <u>submitted</u>** applications were \*started\* in the first minute the portal opened on Monday

### **Ensuring Applicants Had Opportunity to Complete Application**

 All applicants with unfinished applications were contacted via email with instructions in English, Spanish, and Chinese about how to complete and submit their unfinished application by 5pm on Wednesday, April 29<sup>th</sup>

### **Requests for Support/Tech Assistance**

- Over 300 emails (sent to Flashlight requesting support)
- 19 phone calls (to Flashlight requesting support since Monday)
- Spanish language inquiries (have been answered in Spanish)
